“Captiva Memories” will kick off the 2017-2018 art season at the Captiva Civic Center. Freshly rendered works depicting uniquely identifiable people, places and things on Captiva Island are cordially invited as entries in this special juried exhibition. This distinctively Captiva Island annual art exhibition is sponsored by the Captiva Civic Association in association with the Sanibel-Captiva Art League.

- Event Name: Name & Theme: **“Captiva Memories”**
- Work Media: Paintings (oil, watercolor, acrylic, etc.) mixed media, pastels, drawings.
- Entry Fee: \$20 for 1 or 2 artworks
- Awards: First, Second, Third Place and People’s Choice (cash award values tbd)
- Prerequisites: Artwork must be fitted with taut picture wire 3” below the top of the frame and ready to hang when delivered.
- All paintings must be delivered thoroughly dry.
 - No size limitation but weight must not exceed 50 lbs.
 - Plexiglass should be used on any work over 16 x 20.
 - Artist will need to sign a standard contract.
- Timeline: **Opening Reception: Thursday, Dec. 7, 2017 from 5 - 7 pm**
- Exhibition runs through January 12, 2018.
 - Open to public Tues., Wed., & Thurs. 11 am-1 pm & by appointment (472-2111)
 - Open Sunday, Dec.10 following Chapel service (approximately 11:45 to 1:00).
- Entries Accepted: Wed., Nov. 28 and Thurs., Nov. 29 from 11am - 1pm
Pick up for artwork not accepted is on Dec. 4, 10 - noon.
- Juror: TBA
- Miscellaneous: All artwork shall remain for the duration of the exhibit, including artworks sold.
- Pickup Artwork: All works may be picked up Mon., Jan. 15, 10 am - noon or by appointment.
- Publicity: The Captiva Civic Association (CCA) will provide publicity in island papers and to its members via postcards and emails. The Sanibel-Captiva Art League will publicize the exhibition to its members.
- Sales: The Sanibel-Captiva Art League will oversee sales transactions.
The buyer will pay the artist directly. A 25% sales fee for each artwork sold will be paid by the artist to the CCA within 10 days of the last day of the exhibition.

An AGREEMENT Between The
Captiva Civic Association (CCA) and Exhibiting Artist
Captiva Memories Juried Exhibition
Captiva Civic Center - Dec. 7, 2017 through Jan. 12, 2018

The undersigned EXHIBITING ARTIST agrees to abide by the following conditions:

- 1. All art work must be ready to hang with secure wiring fastened to each of the two vertical reverse frame sides for attaching to the CCA hanging system. Works must be fitted with taut picture wire 3" below the top of the frame and ready to hang when delivered.
2. All art work in the show is to be original and available for sale. A legible note depicting tittle, medium, artist name, and selling price for each work must be delivered for art works. All paintings must be delivered thoroughly dry. There is no size limitation but weight must not exceed 50 lbs. Plexiglass should be used on any work over 16 x 20. If any questions, please call 239-472-2111.
3. The CCA Art Committee installs and takes down all artworks for the exhibition. The artist agrees to deliver and remove original art works on the Entry & Pickup Dates noted below. Once installed, art works shall not be removed or exchanged at any time during the specified exhibition time.
4. An Entry Fee of \$20 for up to two artworks per artist will be collected on the Entry Acceptance Day(s). These fees will go toward cash awards for 1st, 2nd and 3rd place artworks selected by the Judge that best represents the Captiva Memories Exhibition Theme. A Sales Commission Fee of twenty-five percent (25%) on all works sold during the exhibition will be paid by the Artist to the CCA within 10 days of the last show exhibition date. The Artist shall remit a 25% sales fee on all sold commissioned works resulting from this exhibition for a period of three months following the close of the exhibition. The Sanibel Captiva Art League will handle all sales of this exhibition.
5. The times and days the Exhibition at the CCA Hall open to the public for viewing will be scheduled and announced in advance. Artists shall make every effort to be present at the opening reception. The CCA reserves the right to reschedule viewing times as necessary. The CCA will provide an Opening Reception for the Artist(s) and include refreshments. As the Dec. 7th Exhibition Opening Reception is held in conjunction with the CCA Holiday Social, all Artists and CCA members are encouraged to bring their favorite appetizer to share. The CCA will provide light refreshments and make available a full (donation) bar.
6. The CCA will provide local publicity promoting the show to the public. Invitations to the opening are mailed to CCA members only. Artists may request postcard invitations for their own use by calling the CCA on (239) 472-2111.
7. A standard waiver (below) shall be signed by the Exhibiting Artist. Any deviation from this contract must have prior written consent of the CCA Art Committee Chairperson. The CCA ARTS Committee and the Exhibiting Artist agree that the above conditions, provisions and policies will be in effect during the Art Exhibition beginning Nov. 28, 2017 through Jan 12, 2018.
